**LEGISLATIVE COMMITTEES TO MEET IN LAS VEGAS
ON REAPPORTIONMENT AND REDISTRICTING**

The Nevada Legislature will hold a joint committee meeting in Las Vegas on April 2, 2011, to receive testimony from the general public on reapportionment and redistricting. The hearing will provide members of the public the opportunity to learn about how the process works and to voice their concerns on this critical issue.

The Senate and Assembly Committees on Legislative Operations and Elections will meet jointly beginning at 10 a.m. to provide Las Vegas area residents an opportunity to make suggestions on redrawing the boundaries of congressional and state legislative districts, the Board of Regents, the State Board of Education, and petition districts.

Interested Nevada residents are encouraged to attend the meeting and present their thoughts and suggestions on reapportionment and redistricting. While some legislators may attend by video conference from Carson City, all members of the Legislative Operations and Elections Committees are expected to attend.

For those who cannot attend the meeting in person, video conference links will be provided to Room 4100 of the Legislative Building in Carson City and to the Great Basin College in Elko. The meeting will also be broadcast live over the Internet via the Legislature's website at: www.leg.state.nv.us.
